4. Parish Council Chair Annual Report – Cllr Hilary Wickham

The financial position is healthy and looked after very efficiently by our Vice Chairman Paul Featherstone who will be reporting in more detail later in the meeting. Our clerk has been aware of all possibilities in acquiring grants for the various new projects initiated. Through these grants this year we have achieved the installation of the Defibrillator and the Speed Radar signs and our next project of the redesign and build of a new website is well underway.

Planning has not been a big issue for us this year. There are now safety signs in place at the Slapton Bridge T Junction but the fencing appears to be only half done and we must follow up on it. The condition of the road to Towcester has certainly improved and after much hassle the new roundabout appears to be greatly favouring traffic from Wappenham and Abthorpe. Freedom of the Parish has been recently mentioned on the Agenda and the merits or not of the plan are still under discussion.

I shall not be standing for re-election at the Annual Parish Meeting next week and so I would like to take this opportunity of personally thanking my fellow Councillors, particularly Paul Featherstone who has been such great support to me over recent years. Our thanks go to Liz Hart who with a busy life has managed to keep us on the straight and narrow and has been involved with the teething problems of the new website. 7. Observations from the County Councillor -Cllr lan Morris

Report detailing County Council Activities 2016/17

This is my fourth report as your County Councillor; the purpose of which is too highlight the activities of the County Council, my role and the current plans that the new Council (after the Election in May) will be following.

Since May of last year I have been a Cabinet Member. The new leader Cllr Heather Smith asked me to take over the Environment, Development and Transport portfolio. A role that takes in Street Lighting, Waste, Highways, Broadband and potholes amongst other things ...so not much of a challenge there then. I will return to this as my report progresses.

Some brief headlines follow:-

Since 2013 we have provided safety for 3,100 of the most vulnerable children in the county and at any one time we have 1,000 children we care for .

Our Invaluable fire and Rescue service has attended around 4000 incidents and this number of incidents continues to fall.

Since 2012 we have created 13,474 new school places

Our Library Plus centres are being used more than ever and will have been visited by over 3,000,000 times this year.

Our Country parks have been visited by 2,000,000 people.

We have repaired 40,000 potholes this year alone.

I now wanted to take some time to specifically discuss our highways and our potholes. In Northamptonshire we continue to focus on innovative ways of maintaining and improving the roads, while maximising value for money. This against a backdrop of budgets that are under increased pressure. The public recognises that the roads require a great deal of attention, as surfaces have suffered due to underinvestment in the past and the cumulative effects of severe winters. In recent years we have received additional 'windfall' money from the government for potholes.

August 2014 - £3.3million

January 2013 - £3.7million available for the maintenance over the following two years.

While this is very welcome – it represents a drop in the ocean compared to what is required to bring roads up to a 'good' standard – which we estimate to be more than £350 million. Any highways issues can be reported through Street Doctor at www.northamptonshire.gov.uk/streetdoctor. The more a pothole or a problem is reported the higher up the priority list it goes so do persevere. This winter has been unusually wet and this has caused some worsening conditions on our roads. We gritted the roads 63 times this winter more than last year which may surprise some people and this combined with the rain to cause further damage to our roads. A programme of road repairs will now be rolled out as the weather improves and we should all see a marked improvement over the summer.

The provision of local bus services will continue to be under pressure and where services are underused unlikely to remain in the sort to medium term. This means that innovative work like our total Transport plan for the entire community may take a significant role in protecting and providing local bus services in the future. Essentially this is a ground breaking new venture that will see the County Partnered initially with the University of Northampton and the Northamptonshire Healthcare foundation trust and which will essentially make use of spare vehicles to provide transport for Schools the Health Trust and the university but this could be expanded to include park and ride and eventually new bus routes into rural areas. The cost of the initial exercise is being entirely funded by government and is being closely watched by other countie.

Northamptonshires rollout of superfast Broadband continues at pace. We were one of the first councils to accelerate rural broadband connectivity . Last year over 43,000 premises were connected and 181 new fibre cabinets were deployed across the county . This year 65,000 more premises have been connected. The phase 3 part of the contract with Gigaclear will see further rollout to the rural areas that have up until now not had any broadband or little chance of connection to superfast broadband and by the end of 2017 we should see 98% of properties connected . In particular those properties with

exchange only connections should see a solution that allows them to connect to the network .

In terms of the Council Tax we still have the lowest council Tax in the country despite having to put it up by 4.99~%. This is broken down into the 3% extra we have been allowed to charge for adult social care (£11.7 million) and the 1.9% we are allowed to increase it by without having to go to a referendum. This effectively is saving the taxpayer at least £102 a year compared to the national average.

Regarding our budget . Despite the on going pressures from Adult Social care and Children's services and unprecedented growth in demand for both we have once again balanced our budget and will do so going forward.

Future changes to government funding to 100% retention of business rates by 2020 with no government grant meant that all Local Authorties will have to look at how they operate going forward . This county currently has nine local authorities including the County , Town , Districts and Boroughs and over 400 elected Councillors . I have long been an advocate for some form of unitary authority in this County and this is something that the next administration will have to look at . To be very clear this is not a take over of the Boroughs , Districts and Towns by the County but a redesigning of the entire system . All nine Authorities would cease to exist and a new one would be formed with all new Councillors and officers . The savings to be made and therefore spent on front line services are large and cannot be ignored going forwards . The number of unitary authorities might be up for debate but it is my opinion that one makes the most savings and any more than two begins to water down the savings significantly . whatever model is proposed the people of Northampton would be fully consulted with and ultimately it would be your decision.

I wanted to finish with a mention of the councillors empowerment fund . many if not all of the villages within my division have benefited over the last four years from the annual amount of this fund. It has been reduced this year and next to £5k a year . it is something I will fight to retain going forward.

8. Observations from the District Councillor - Cllr Peter Davies

Finance

The pressure on local government finances continues, as central government strives to reduce its budget deficit. The Revenue Support grant to SNC fell by £600,000 in 2016-17 to £812,000. In the current financial year 2017-18 this is falling again to £287,000 and next year will disappear entirely.

At the same time Rural Services Delivery Grant, recognising that it costs more to deliver services in rural areas, drops from £187,000 to £151,000 this year

Despite these problems SNC achieved a balanced budget for the past year and remains debt-free. Other councils have not fared so well

Joint working

Last year I mentioned the savings that were being made through joint working with Cherwell Council, especially in back office and IT areas. This has been extended to include joint planning teams, legal and senior management. I said last year that savings from joint working amounted to over £3 million so far. Work continues to identify further economies.

A debate is now going on about more wide ranging reorganisation, including the abolition of district councils into mega Unitary Councils, centred on whole counties. Apart from the logistical problem of providing local services from a more distant hub, there is also the issue of council debts - would we want to be linked to other council's debts?

Council Tax

You will have noticed that your Council Tax increased this year. SNC takes just over 11% of the total, for services which include housing, town planning, licensing, refuse collection, recycling, elections, fly tipping, pest control - the list goes on. 70% of Council Tax goes to NCC and 13% to Northants Police and Crime Commissioner. Parish Councils got 2%

Business Rates

The Rating List is updated every 5 years. For SNC there has been an increase of 5.6% in rateable values, reflecting partly the increase in business activity in this part of the county, compared to a national increase of 11%. There has been a lot of comment in the national press about the damaging effect on some businesses. I would just say there is an appeal system in place for anyone who considers they have been assessed unfairly, but any appeal needs to be made early.

New Homes Bonus

The government is reducing the payments from 6 years to 5 in 2017-18, resulting in a loss of £190,000 this year. This will be further reduced to 4 years in 2018-19, meaning a bigger loss of revenue.

The total local community funding allocated to Wappenham is £4,459 of which £3,682 remains unspent

And I should remind you that other funds may be available under the Community Development Capital and Revenue schemes.

The Local Plan

SNC Local Plan Part 2 is currently looking at all village confines. So now is the time to consider if changes in the current boundary need to be made. Mainly it is to tidy up any anomalies but there is also the point that it is easier to get planning permission for building changes inside the village boundary than outside it.

We are all aware of the huge amount of house building in progress around Brackley and soon to be for Towcester as well. The congestion on the A5 through the town centre should be eased with the construction of a relief road from opposite the race course to the A43 south of Towcester, due to begin in 2020.

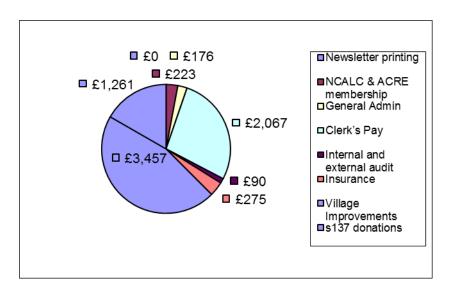
All councils are required to have a 5 year land supply, without which a planning inspector can allow any development on appeal. South Northants has more than that, but still no identified travellers' sites.

Finally I should mention that SNC and Cherwell's joint chief executive Sue Smith retired last month and her replacement Yvonne Rees currently working with Surrey and Essex councils, selected from forty applicants, takes up the post in June.

9. Parish Council Financial Statement for y/e 2017 and budget for y/e 2018 PC - Cllr Paul Featherstone (PC financial internal control officer)

- We closed this year with £2838 in the bank accounts; this compares with last year's £5337 closing figure.
 The decrease is due to spent monies received the previous year on the Speed Radar Project. The closing figure is back in line with previous years (2015 was £2842.)
- Total expenditure was £7549; this compares with £3160 the previous year. The increase is due two
 projects being completed: the Speed Radar Device was £2592 with posts costing £570 whilst the
 defibrillator was £1115. (£657 is due to be reclaimed in VAT from these projects)
- We received £596 from Northants CALC to design a new website and associated costs to be spent in this financial year. On-going costs will need to be budgeted for.
- There were no newsletter costs incurred due to significant advertisers' contributions.
- The precept for 2017-18 is £2,828, up from £2,773 last year; the Parish Council is taking £300 from reserves this year to meet the budgeted expenditure of £3131.
- £100 of this year's budget is set aside for donations to village groups/ organisations.

Report

Rupert Fordham continued as Chairman of the Trustees for the distribution of the awards, and Phyllis King, Philip King, Rev Carole Peters, Jenny Szczerbowski and Hilary Wickham continued as Trustees.

Over the course of the year no special requests for financial assistance were received.

The sum made available for distribution for the St Thomastide Grants by the Trustees was £800. Two cash awards were made.

As last year, we also made small gifts to a number of residents who it was felt had suffered a period of distress for whatever cause, (perhaps illness, losing a job or family issues). 12 gifts of this nature were delivered, and as before, these were well received.

Again, the Trustees decided not to distribute all the money received, but rather to save some. As a consequence, the charity now has over £2,100 in reserve. The purpose of the charity is to help people in Wappenham who find themselves distressed for whatever reason, and the Trustees would therefore be happy to consider requests, perhaps of a practical nature, during the course of the year, as well as at Christmas time. They would welcome the help of the PCC and the Parish Council in this respect.

As ever the accounts of the charity can be made available to any independent Auditor nominated by the Annual Meeting should this be deemed desirable.

Report from the Rector

This is my 4th report to the Village Assembly and looking back over the 12 months we have had both good and bad times.

The theft of the lead from our roof was a particular low point and my thanks go to those who launched the over-night security Rota. I am told that the stars and wild life are particularly wonderful at 3 in the morning!

A serious back problem caused me problems this year and meant that some services and activities were curtailed, but I am pleased to report that the medical procedure undertaken on my spine seems to have done the trick and I am back to fighting form!

It has been good to see St Mary the Virgin become more mission orientated over the past year. We have been prepared to stop initiatives that aren't working and even embark on new ones both as a PCC and jointly with other Churches in the Benefice.

Our regular and special services continue to provide varied worship that encompasses both traditional and contemporary styles. Sadly none of our services have seen expansions in regular, tiny congregations, but I am so pleased to say that our "fresh expression" - Village Praise and Prayer is still attracting different worshippers from our community.

Our other regular services, our two Eucharists (on the first and third Sundays) have seen overall numbers remain frustratingly static, even dipping during holiday times, but our new initiative – Breakfast Church – a pastry and bacon butty breakfast with proto relaxed worship in the form of a quiz, children's activities and discussion is proving popular with all ages.

Sadly as a PCC we opted not to continue with our regular monthly Messy Church, instead we shall concentrate on Messy Christingle and Messy Mothering Sunday and we are inviting those who attended our Messy Church to join in at other Messy Churches operating monthly at Helmdon and Syresham.

Outside of our regular service pattern this year we joined forces with neighbouring Parish Lois Weedon and Weston to cerate a hugely successful "Harvest in the Barn" which saw record numbers attend both the service and the supper and auction that followed. Our grateful thanks go to Sheena and Ashley Warren for allowing us to us their barn.

Wappenham still hosts Benefice Sunday Services as well as their September Patronal celebration, while our Christmas and Easter Services were as great a success as ever. This year we played host to the first stage of our Benefice Palm Sunday Worship with a procession with donkeys from the Village Hall.

This year has not been a busy one for the Occasional Offices we like to hold, with only one baptism, one Wedding, but unfortunately the Church hosted two funerals, both for well loved members of our local community.

We have continued to build on our relationship with St Loys School, where many of our Village children go and as well as taking the regular Tuesday morning assemblies.

On a social note we had a good presence behind the bar at the Beer festival, which reflected in the amount raised and the funds that came back to the Church through a generous donation from our Friends and huge thanks to them for all their tireless fund raising for our steps and now our roof alarm and repairs.

Our Churches could not continue to operate as places of worship without the kind donation of the times of countless volunteers, who clean the church, dress it with wonderful flower displays, tidy and mow the church yard, deliver our magazine and support our services and fundraising efforts – thank you every one of you.

I would also like to offer a very personal thank you here to our Churchwardens and PCC, who have worked alongside me and been very supportive of all we do for Christ in this Parish.

The Future

Sadly, as a Benefice, we cannot be said to be in the rudest of health at the moment. With small congregations and increasing bills such as the Parish Share, the future might be fragile if it was not for the desire across the Benefice to work more closely together, offering support, jointly working on fund raising initiatives and seeking holistic solutions to the problems that beset the rural church.

Our Benefice PCCs have jointly appointed a Working Party, who will investigate solutions to the problems we face and report back to our PCCs later in the year.

Our prayers are with the working party and those who are advising them. I hope we can achieve a Vision and an Action plan for the future of ministry and mission in these parishes and that with this we can work towards a future that furthers God's Kingdom as we serve the Lord and this community in faith and love, here in the Astwell Benefice.

Friends of St Mary the Virgin Report year ending 2016

Introduction

The Friends continued to raise funds during 2016 whilst awaiting information on the likely cost of our major project, repairing the church tower steps.

Treasurers' Report

The Friends' funds stand at £15,730 (£10,710 in 2015) of which £750 is earmarked for the WC. Income in 2016 was approx. £5,300 and outgoings were approximately £700 for the servicing of the clock. There is also outstanding Gift Aid awaited of approx. £2,500.

Works and Faculties

Tower Steps and north porch roof

Following the Quinquennial Review of 2014, the decision was made to focus primarily on repairs to the tower steps and then tackle the north porch roof. The cost was estimated to be £20,000, approximately £300 a step.

Whilst expert professional advice was sought the Friends began raising money, inviting residents to 'sponsor a step' in memory of a loved one, to be commemorated on a plaque in the Church. Such donations make up the bulk of the monies received. The Faculty was received and applications were made to likely charitable sources, so far with only slight success. Due to the continued generosity of local residents, a final decision to go ahead will be made at the PCC June 2017 meeting.

It was agreed to appoint an architect from the Diocese's approved list to advise on repairs to the north porch roof. Several ideas were being considered for dealing with the drop at the back of the pulpit.

Kitchen and WC

Progress was previously reported in that we have, thanks to the Tove Valley Broadband works, now got a water pipe which runs from the stand

pipe at the gate up into the boiler room. The next stage is to bring water into and drain it out of the Church possibly via a soak away.

Fund-raising events

The Church/Friends participated in the third Wappenham Beer Festival on Saturday 25 June, sharing the proceeds with the Village Hall. This was our major fund-raising event of the year and raised over £715 which had gone towards church maintenance such as upkeep of the Clock.

Thanks also to Di for the continuing sales of Wappenham themed tea towels.

May I thank all the hard working and enthusiastic members of the Friends and our supporters!

Money has been obtained in the form of grants to have a structural survey undertaken and it is hoped that the work will be covered by our insurance.

All in all the hall continues to be well used and we hope that this year we will be able to resolve some of the ongoing building issues.

Slapton and Wappenham Evangelical Church

Hosting

The website is still hosted by Northampton school for boys (NSB) (since 2003.2004). I believe there have been discussions about moving the website to another host (see PC minutes 6 April 2016).

PC documents

Katherine Hart is now uploading PC minutes and Agenda onto the web in line with government good practice. The draft minutes of all Council, Committee and Sub-committee meetings should be published no more than 1 month after the relevant meeting. Agendas and full working papers for all Council, Committee and Sub-committee meetings should be published at least 3 clear days before the relevant meeting.

Future

The website needs a total revamp. This should be done every 2 years and is very much overdue.

A Responsive web design approach needs to be taken to provide an optimal viewing experience across a wide range of device. Smartphones, tablets, etc. This is no longer a design option. Most people view websites on their portable devices as well as desktop computers. The PC will need to find a person/organisation who has the know-how and can design a robust website with engaging and usable web interface.

The current website no longer conforms with the World Wide Web Consortium guidance and good practice. Coding / style for e.g. CSS (cascading style sheets) version used is outdated. I expect that some visitors may not even be able to scroll or view the website properly.

I no longer have the capacity to post contributions, update, modify or redesign, the website. The website is slowly turning into a repository for various community documents. The PC / Village needs to find a new webmaster who can carry out all of these tasks or split the tasks between a web designer and a web content administrator/manager.

12. Refurbishment of the Rose Window

The central rose is to be repaired; it is not decided if this is to be plain or decorated. It was confirmed that the brickwork is original and would not be removed.

13. Open Forum

The possibility of having Andrea Leadsom speak in the village regarding Brexit was mooted; it was suggested it would also be appropriate to have someone with a different view to speak.
